Failure to do so may be seen as abandoning studies and students may be reported to the Department of Home Affairs.</li> <li>• Students have the right to appeal through Australian School of Commerce's complaints and appeals process, in accordance with standards 10 (Complaints and appeals) of the National Code 2018, within 20 working days. The deferment, suspension or cancellation will not take effect until the internal appeals process is completed, unless the overseas student's health or wellbeing, or the wellbeing of others, is likely to be at risk.</li> </ul> <p><b>Please note:</b> It is advised that students should not leave the country unless student has a valid deferment or suspension, as cancellation of enrolment and abandoning your studies might lead to cancellation of your visa and you may not be allowed to enter Australia.</p>
